- 1.0 Call to Order Greetings and Introductions Nicola Baker, COPAC President
- **2.0 Guest Speaker** Delta Carmichael Secretary Treasurer/CFO & Kate Cumming Assistant Secretary-Treasurer presented the background and high-level summary for the draft 2024/2025 SD23 Budget
  - 4 Focused Directions for SD23 2021-2026 Strategic Plan (approved by the Board of Education June 9th, 2021)
    - Equity & Excellent in Learning
    - System Wellbeing
    - Transformative Leadership
    - Family & Community Engagement
  - **SD23 Funding driven by FTEs** (full-time equivalents) as defined as a student taking a full course load, and not by head counts as defined as how many employees/students in a building/a particular school
  - 4,495 staff serving 49 schools/sites (5<sup>th</sup> largest district in the province) and serves over 25,500 students)
    - o 32 elementary, 8 middle, 5 secondary, 1 alternative school, 1 online learning (K-12)
    - 3 learning centres
  - SD23 Financial Income Sources 3 SEPARATE FUNDS
    - 1. <u>Operating:</u> Main operating expenditures. comprises of approx. 83% of budget (incl. Instruction, District Admin, Operations& Maintenance, Transportation)
    - 2. **Special Purpose**: Targeted funding for a particular purpose—comprises approx. 12% of budget. (includes Feeding Futures, Student & Family Affordability, Classroom Enhancement Fund, CommunityLINK, Annual Facility Grant, School Generated Funds.) \*Classroom Enhancement Fund based on Supreme Court decision in 2017/18 to assist SDs with implementation of the restored class size and composition limits. Total Special purpose budget is \$43,230,121 (2023=\$38,113,113).
    - 3. <u>Capital:</u> This fund includes the capital assets of SD23 and in 23/24 accounted 5% of total budget (i.e. land, buildings, equipment, vehicles and Refresh program).

A Five-Year Capital Plan is approved by the Board of Education on an annual basis. Total budget is \$19,211,478 (2023=\$16,751,194) \*\*MECC will announce funding for 2024/2025 budget in March 2024\*\*

## Trustee Update - Trustee Chantelle Desrosiers

- Thanks to the voting members of Finance and Audit committee for being present during this year's annual public presentation of our school district budget during COPAC general meeting
- Several water main breaks in our district in January, Trustee Desrosiers highlighted AME and extended thank you messages to the AME families for their patience and understanding, AME staff & administrators with the complexities of moving students to other school sites, the neighbouring schools that opened their doors and welcomed AME in, and our operations department for getting it up and running. And special thank you to one of our custodial staff without their quick thinking and ingenuity there would have been a lot more damage to AME.
- Next Policy meeting will include some recommended changes to SD23 policies:
  - -Policy 405 Student Placement, reflects the new legislation regarding Bill 40 providing indigenous students with school of choice.
  - -Policy 630 around Naming of schools. Recommendations are around naming of **FUTURE** schools around historical, geographic or operational characteristics VS. individuals.
  - -Policy 703 Relations with Parents and Students- recommendations came back to COPAC for review regarding parent/guardians filling PAC executive positions that are employed with SD23 for 10 hours or more.

- -Policy 135 regarding suspension of the second question and comment period at regular School Board meetings
- Next Planning & Facilities February 7<sup>th</sup> Annual Facilities Grant (AFG) 3 year submission will be presented

# Superintendent Update- Kevin Kaardal

- Added thanks to the senior team regarding the frozen waterline at Anne McClymont Elementary school and planned move to find spaces, our TTOCs-providing relief in 3-4 classes in gymnasiums supporting teachers, and Bus drivers that took on extra bus routes. And thank you to CUPE staff for assisting / procuring materials from outside sources.
  - It took a community to make sure our kids continued to be educated during this challenging time.
- Premier Eby announcement: restriction of Cell Phone Use in schools- SD23 is waiting for further direction from the MECC prior to the September 24th deadline to establish policies on restrictions on cell phone use in classrooms from the MECC.
