6.0 SD23 PARTNER GROUP REPORTS

Trustee Update – Trustee Leanne Tiede

- Due to Spring break not much too share tonight, lots going on in our district with more info to be shared soon.
- o The Board will be attending the BCSTA AGM and put forth a motion that was accepted to Advocate to

the Ministry of Finance to increase MOECC Annual Facilities Grant (AFG) so that school districts may address the accumulating cost of deferred maintenance to improve accessibility ensure student safety enhance learning environments and extend facility life expand and support long term fiscal responsibility.

 COPAC President shared that in collaboration with some partner DPACs will be submitting resolution to BCCPAC to advocate for AFG funding as well.

Superintendent Update- Kevin Kardaal

- o Amid the proposed SD23 Budget for 2024/25 school year, to be finalized within the next few weeks.
- Even though we have a cost pressure primarily due to growth, the district will be adding staff and not having to cut any services.
- Parents/Guardians encouraged to attend next Finance& Audit meeting where answers will be shared regarding some questions and concerns that were brought up by the committee.
- Through advocacy efforts, SD23 has now been included in a provincial group for fast growing districts, who also have multitude of issues like staffing recruitment, and space for students to support the growth districts are experiencing.
- Upcoming BC School Superintendents Association (BCSSA) Spring Conference- SD23 has been selected to
 present based on student advocacy with some of the work that's going on around Environmental
 education and prototypes.
- o Encourage parents to continue advocating for more student spaces
