6.0 SD23 PARTNER GROUP REPORTS

Trustee Update – Trustee Wayne Broughton

- 2024/2025 SD23 Budget. Provide feedback online via survey that has been open for the last month. Survey closes tonight.
- o February Policy meeting included some recommended changes to SD23 policies:
- -Policy 703 Relations with Parents and Students- regarding parent/guardians filling PAC executive
 positions that are employed with SD23 for 10 hours or more. The final decision was to not proceed
 with the amendment, but rather amend Policy 390-Conflict of Interest and Confidentiality at a future
 policy committee meeting.
 - -Policy 630 around Naming of schools. Recommendations are around naming of **FUTURE** schools around historical, geographic or operational characteristics VS. individuals.
 - -Policy 135 School Board Operation: suspension of the second *public question/comment period* at regular School Board meetings will continue
 - -Policy 405 Student Placement, aligns with the new legislation regarding Bill 40 providing indigenous students with school of choice and will get priority.
 - -At last Board meeting, approved deletion of <u>Policy 505-Learning Assistance</u>. Trustee Broughton stated there was a lot of discussion about this and clarified that this is part of the Boards effort to clean up the very large number of policies that are more appropriate under Human Resources department as they are basically providing job descriptions. Trustee Broughton shared that will not change the role of Learning Assistance teachers
- Approved new Board Authority Authorized (BBA) elective course "Holocaust 12: Beyond the Shoah".
 Locally developed course by KSS and RSS Teachers
- Board submitted the <u>Annual Facilities Grant (AFG)</u>. (page 17 of Board of Education Public meeting Agenda Package)
 Every three years school districts are required to submit to the Ministry of Education and Childcare.
 AFG funds are used to do maintenance on buildings (roof repair, HVAC, washroom upgrades, electrical, etc).
- SD23 Board of Education has passed a motion to ask the British Columbia School Trustee Association (BCSTA) to advocate to the government to increase Annual Facilities Grant funding. AFG is underfunded with millions of dollars in deferred maintenance and across the province its billions of dollars in deferred maintenance.
- Finance and Audit committee is recommending that the Board increase Bussing transportation fees for the next school year, from \$400 per student to \$450 to cover the expected increase in students using sd23 buses (2 new bus routes, increased fuel cost) estimating 5,500 students will be using SD23 bussing in September 2024. MOECC only subsidizes a small fraction of the transportation costs which requires our district to take over \$4million dollars out of our operating budget, which takes away from classrooms, to subsidize the school bus system.
- School Fees will remain the same
- Recapped highlights that Board of Education Trustees attended for the recent regional branch meeting for the Thompson Okanagan of BCSTA in Vernon.

Deputy Superintendent Update- Terry-Lee Beaudry

Shared info about our school districts 30-year partnership with Chuba University Haruhigaoka Junior High School in Kelowna's sister city of Kasugai, Japan. Huge thankyou to the families from Glenrosa Middle School and Constable Neil Bruce that served as Homestay parents in February for 4 days. SD23 welcomed 103 students from our sister school in Japan and this has been the first time we've been able to have them in 4 years (since 2019). This continues to be an incredible opportunity of

exchanging students and cultures.

- Received Provincial 2024 Budget announcement focused on Housing, Health, and Climate Change
 - o Provincial level plans to hold contingency funds for wildfires due to anticipated droughts.
 - Some of the positives of this year budget for BC school districts, is the province will fund student enrollment increases -est. over \$650 million of 3 years.
 - Increase over 3 years of \$800 million for Capital, which includes the prefabricated modulars
 - We are one school district of many across the province that are really challenged with minor maintenance and deficiencies of not being able to fund it through AFG funding
 - 30 million dollars over 3 years invested in Literacy Support for K-3 students (early learning screening, advanced intervention for students that require extensive remedial support and professional development for staff). Looking forward to see what that will look like for our school district and how we can support our students in the early year.
 - the Student and Family Affordability fund is expected to come back to support families.
 However, this will mean less money expected for the Feeding Futures funding.
 - Significant challenge is that there are no increases to ministry budget to manage expected inflationary increases
- Due to the required budget pressures sd23 school budget for 2024/2025 year will need be conservative, more information to come over the next few months.

Assistant Superintendent shared update regarding the initial April 2023 meeting with Indigenous Education Council and COPAC President & Vice President on our path towards truth and reconciliation and introduced Jesse Bruce. Discussed with membership in May 2023 COPAC meeting.

Director of Instruction for Indigenous Education and Equity Update-Jesse Bruce

- Discussed three distinct but connected items that are specific to Parent and Family Engagement;
 - 1. inform and provide context to COPAC about Indigenous Education Councils (IEC)
 - Jesse Bruce read the announcement from Ministry website: "The province is proposing amendments to the School Act to fulfil commitments in the Declaration Act Action Plan and the BC Tripartite Education Agreement (BCTEA). The changes are intended to support better education outcomes for First Nations and other Indigenous students attending provincial public schools, and more effective relationships between boards of education and First Nations. The proposed changes take a distinctions-based approach and were developed collaboratively with the First Nations Education Steering Committee and reflect consultation with First Nations and Indigenous people throughout B.C. ... Changes to the School Act will require all boards to establish an Indigenous education council (IEC) in their school district to ensure Indigenous people have input into decisions affecting Indigenous students. The membership and function of IECs will recognize and reflect the local First Nations in whose territories the board operates. IECs will support boards in the provision of ongoing, comprehensive and equitable education and support services for Indigenous students, including providing Indigenous perspectives for the benefit of all students, and advice on and approving the board's spending plans and reports in relation to Indigenous education-targeted funds.
 - Its important to note that while this is a new provincially legislated mandate, Central Okanagan Public School District has had an Indigenous Education Council operating in our district for over 20 years.
 - Currently the Indigenous Education Council is comprised of VOTING members from Westbank First Nation, Lake Country Native Association, Okanagan Indian Band, Kelowna Metis Society, and Ki-Low-Na Friendship Centre. NON-VOTING members include SD23 senior staff and Board of Education Trustees
 - 2. The IEC is in support of 2 voting seats for parent reps, one of which would represent Westbank First Nation. The parents that are selected to be voting members of the IEC will also help to rejuvenate and reestablish the Indigenous Parent and Family Council for our community of learners. The hope is to disseminate this information through COPAC and school-based PACs to find indigenous parent representation. We invite parents/caregivers that self identify having indigenous ancestry that would like to consider contributing to COPAC and/or to the Indigenous Education Council Executive, please reach out to Jesse Bruce jesse.bruce@sd23.bc.ca or COPAC president so that we can help to make connections.

- President Baker reiterated the ask of taking this information to your school PAC and suggested can invite Jesse to come to school PAC meeting to present this information.
- Members from IEC will be creating a one-page information document to advertise and assist with recruiting indigenous parent representation.
