## 2.0 Guest Speaker

Jordan Kleckner, District Principal of Learning Technology, introduced Digital Equity presentation.

• Explored Timeline of technology journey over last 20 years

- Tobias Blaskovits shared results of technology scan where they engaged with IBM, performed district wde review and district student survey. Had high school students saying need more technology learning, adaptability -> Key themes, redesigned curriculum, demand for access, growing demands on network & infrastructure, access, address equity gap between schools, device proliferation.
- Graham Johnson discussed concept of digital divide, and argued that critical focus should be on Digital Equity through increasing opportunities for students
  - loaning out devices
  - supporting families to purchase by providing discounted devices though continuation of district volume purchasing program
  - Concept of having a personal learning device adoption, shift from a shared device model to each student having their own
  - Component of New Strategy refresh technology in schools on more frequent basis, Continue to focus on providing personalized learning,
  - Continue working on wifi infrastructure

Jordan Kleckner concluded that with a rapidly changing technology landscape, there are equity concerns between schools and students, and a need for a "just in time" approach to technology. drivers of digital equity and put out an invitation to PACS to respond with feedback.

## 9.3 Treasurer – Janet D.

General account at \$8741.48 and Gaming account for March is estimated at \$1,105.

Janet confirmed submitting an application for Gaming Grant last weekend. Note regarding BCCPAC registration, Gaming Funds can now be used by PACs to pay for registration. But DPACS are prohibited from using Gaming Funds for PAC registrations. So if COPAC chooses to continue to cover the registration fees then will need to use General Funds.

Janet addressed the requested bylaw change regarding executive term of office, and asked Valary to table the proposed change:

Valary proposed to change Terms of Office section 9. "No Person may hold the same executive position for more than two consecutive years", to be replaced with, "No person may hold the same executive position for more than three (3) consecutive years"

However, Moyra B. clarified (in correction to interpretation noted during prior meeting) that unfortunately the interpretation of the current bylaws is that the membership (which is the PACS) do need to receive notice of the amendment at least 14 days prior to voting on the amendment at the next meeting

Terry L. proposed amendment to the bylaw change to include "in extraordinary circumstances", Jammie P made recommendation to use the wording proposed during the last meeting but change to COPAC Reps instead of members.

## Final wording to be:

9. No person may hold the same executive position for more than two (2) consecutive years. In cases where a person has held a role for two consecutive, one-year terms, and no replacement nomination is put forward, the COPAC Rep's in attendance, by a majority vote of not less than two-thirds (2/3), to extend the term for another year until the next AGM, provided the person holding the position remains a parent or guardian of a student enrolled in SD#23. The maximum consecutive years any person can hold the same executive position, including extensions, is three (3) consecutive years.

Jammie P proposed to accept as amended Jeremy J 2nd Motion passed The accepted proposed amendment is to be emailed out to PACs
